## Code of Conduct

Members and their guests are expected to conduct themselves in a respectful, responsible manner.

At no time will the following conduct be permitted:

- Exhibiting immoral or disreputable conduct;
- Assaulting or attempting to assault a member, guest, or bystander;
- Carrying any weapons or dangerous instruments to shag meeting, dance, or other shag related event unless properly licensed;
- Wearing clothing that is considered indecent or contains inflammatory or pornographic words, insignias, emblems, or images;
- Discriminating against, harassing, or making inappropriate sexual advances toward anyone at a shag club function;
- Deliberately damaging or destroying property or equipment at a shag club function (*N.B.: In the event of property damage or personal injury, the person(s) responsible will be expected to make full restitution for the damages and/or expenses incurred*);
- Any other personal conduct adverse to the best interests and purpose of the club.

Members found to be in violation of this Code of Conduct will be subject to suspension or expulsion from the club. The length of the suspension or expulsion will be based on the discretion of the Board of Directors. In the event of expulsion all dues will be forfeited.

## Release Form

I agree that the Mountain Empire Shag Society Inc (MESS) of Johnson City, TN and its respective officers, directors, employees, owners and operators of MESS event sites, and agents (Herein after, the “released Parties”) shall not be liable or responsible for injury to me (including paralysis or death) or damage to my property during any MESS club activities, even where the damage or injury is caused by negligence (except willful neglect).

I understand and agree that all MESS club members and their guests participate voluntarily and at their own risk in all MESS club activities, and I assume all risks of injury or damage arising out of the conduct of such activities, any pandemic, or any act of God.

I authorize my permission to be used in club photos, press releases, on club website, or in videos for MESS public relations materials.

I release and hold the “released Parties” harmless from club activities and events. I understand that this means that I agree not to sue the “released Parties” for any injury of damage to myself or my property resulting from, or in connection with any MESS activities, events, any pandemic, or act of God.

By signing this release, I certify that I have read this release and fully understand it, and I am not relying on any statements or representations made by the “released Parties”. By signing, I have also read and understand the MESS Code of Conduct as well the possible actions that may be taken by the Board of Directors should a violation occur.
